### 3. Purposes and legal basis of the processing

### 4. Recipients or categories of recipients of personal data

Depending on which publications you have consented to in the declaration of consent, the images and sound recordings may be forwarded:

- internally where applicable to BfR employees (Risk Communication department, Media and Public Relations) and/or
- to external service providers (e.g. agencies, printers) in the context of producing BfR print and online products for the purposes you have consented to.

Recordings are stored in the BfR internal database of images which is located on a BfR server.

Where images, videos or sound recordings are published on social media channels, the data is being transmitted to and processed by the operators of the social media platforms. ## 7. Rights of the data subject

You have the following rights towards the BfR with regard to your personal data:

- the right to information according to Art. 15 GDPR,
- the right to rectification according to Art. 16 GDPR,
- the right to erasure according to Art. 17 GDPR,
- the right to restriction of processing according to Art. 18 GDPR,
- the right to object under Art. 21 GDPR,
- and the right to data portability under Art. 20 GDPR.

The restrictions in accordance with Articles 34 and 35 of the German Federal Data Protection Act (BDSG) apply to the rights of access and erasure.

You may withdraw your consent at any time with future effect. This does not affect the lawfulness of processing carried out prior to the withdrawal of consent.
