

The German Federal Institute for Risk Assessment (BfR) is the national institute which prepares expert reports and opinions on questions of food, feed and chemical safety and consumer health protection in Germany on the basis of internationally recognised scientific assessment criteria. It advises the Federal Government and other institutions and interest groups in these areas. The BfR conducts its own research on topics that are closely linked to its assessment tasks. It is an institution with legal capacity within the portfolio of the Federal Ministry of Food and Agriculture (BMEL).

Part-time employment is possible. The fixed term is based on the Wissenschaftszeitvertragsgesetz.

Tasks:

The BfR is responsible for aspects of application safety in the authorisation of plant protection products and in EU active substance testing. Within its legal remit, the BfR is responsible, among other things, for reviewing and evaluating documentation on toxicology, dermal absorption, exposure, classification and labelling and for deriving risk mitigation measures for the products with regard to the protection of users and uninvolved third parties.

In detail, the activities include

- Scientific evaluation of application documents to assess the toxicity and dermal absorption of plant protection products and proposals for classification and labelling in accordance with the requirements of the legal procedures
- Model calculations to estimate the exposure of professional operators and uninvolved third parties to plant protection products
- Scientific contributions to the health risk assessment for application safety and preparation of assessment reports in the legal procedures, including the derivation of safety instructions, measures and warnings to ensure a safe use of plant protection products when used as intended
- Participation in the further development of assessment concepts on the toxicology of plant protection products and on application safety
- Collaboration and representation of the BfR in national and European committees on health risk assessment issues

- Completed university degree (Master's degree, diploma or comparable university degree) in toxicology, medicine, chemistry, veterinary medicine, biology or a comparable specialisation,
- Very good knowledge of toxicology
- Experience in the field of health risk assessment (in particular Regulation (EC) 1107/2009, Regulation (EC) 1272/2008)
- Very good knowledge of written and spoken German and English
- Very good computer skills as well as a conscientious way of working, flexibility, ability to work in a team and under pressure as well as the willingness to travel are required
