#### Appendix 1:

#### 2) What sources and data do we use?

We process data that we receive from you as part of your application.

## 3) What do we process your data for (purpose of processing) and on what legal basis?

We process your personal data in accordance with the provisions of the General Data Protection Regulation (GDPR) and the Federal Data Protection Act (BDSG-neu).

Your application data will be processed to execute the application process at the BfR. Contact data such as name, address and email address are collected for the purpose of contacting you in connection with the application process and the use of the application management system. The legal basis is Art. 88 GDPR in conjunction with Section 26 I 1, VIII 2 BDSG-neu.

In addition, if necessary, we also process your data in order to balance of interests in accordance with Art. 6 I f GDPR, e.g. to assert legal claims and to defend against legal disputes or based on legal requirements in accordance with Art. 6 Lc GDPR.

### 4) Who will receive my data?

Your online application will only be checked by the departments involved in the respective job recruitment process. These are only persons who are directly involved, such as the responsible managing director of the commission, relevant persons from the Executive Committee and representatives of the bodies involved, such as the Equal Opportunities Officer of the BfR or the members of the Appointment Advisory Board.

The data will not be used for other purposes that are unrelated to the application.

# 5) Special categories of personal data

We would like to point out that applications, in particular CVs and other data you send to us, contain so-

called "special categories" of personal data (e.g. mental and physical health, ethnic origin, political opinions, religious or philosophical beliefs, membership in a trade union or political party or sexual orientation).

The BfR does not need this information to process your application.

If you provide us with information of this type in your online application, you do so voluntarily. The processing then takes place in accordance with Art. 9 II b) GDPR pursuant to our data protection declaration and applicable law, in particular the General Non-discrimination Act (AGG).

## 6) Security safeguards and transmission

We use technical and organisational safeguards to ensure that your data is protected against accidental or intentional manipulation and unauthorised access.

The processing of your data takes place exclusively in Germany.

# 7) How long will my data be stored?

Your complete data will be stored for up to one year after the application process has been completed. In the event of an appeal, your contact details (correspondence address) used for establishing contact and arranging appointments will be retained. In the event of rejection, the data will be erased after one year at the latest.

# 8) What data protection rights do I have?

Every data subject has the right to information in accordance with Art. 15 GDPR, the right to rectification in accordance with Art. 16 GDPR, the right to erasure in accordance with Art. 17 GDPR, the right to restriction of processing according to Art. 18 GDPR, the right to object under Art. 21 GDPR, the right to revoke consent at any time according to Art. 7 GDPR

as well as the right to data portability from Art. 20 GDPR. The restrictions according to Sections 34 and 35 BDSG-neu apply to the right to information and the right to erasure.

In addition, there is a right of appeal to a data protection supervisory authority in accordance with Art. 77 GDPR in conjunction with Section 19 BDSG.

## 9) Am I obligated to provide data?
